

INSTALLATION INSTRUCTIONS


01. Remove factory air intake tube. Loosen clamp on throttle body and MAF (8MM driver or flathead screwdriver) and release 2X CCV hoses that go from the valve cover to the intake tube.

Remove the tube assembly from the vehicle.





02. Remove factory PCV hose from the vehicle by pushing down on the white tab on the fittings while pulling on the hose. Use caution removing these components as they can be damaged with excessive force.

03. Install the 2X Fittings into the catch can and tighten with a 17mm wrench. Install the bracket onto the catch can using the 3X M4 Bolts as shown. Note the orientation of the fittings. Do not fully tighten the bolts at this time.



04. Locate and remove the 13mm bolt attaching the fender brace to the firewall on the driver's side of the engine bay. Install the catch can bracket under the bolt and tighten. Note the orientation of the bracket.



05. Route the hose with the 45-degree fitting from the male fitting on the intake manifold to the "OUT" fitting on the catch can and secure with the provided hose clamp. Route the hose underneath the wiring harness above the valve cover for a clean look. You may trim the open end of the hose if necessary.

06. Route the straight hose from the PCV fitting (under the throttle

body) to the "IN" fitting on the catch can and secure with the provided hose clamp. Route the hose underneath the wiring harness along with the other hose. You may trim the open end of the hose if necessary.







- 07. Adjust the orientation of the catch can and tighten the 3X 2.5mm allen head bolts.
- 08. Reinstall the factory intake air tube assembly.
