## **Limited Lifetime Warranty**

**For How Long:** This warranty, and any implied warranties including merchantability and fitness for a particular purpose, last as long as the original retail purchases owns the vehicle on which the product is installed. The warranty expires if the product is removed from the original vehicle or if the original vehicle is transferred to another owner. The warranty is not transferable from the original purchaser.

## Limited Three Year Warranty

What is Covered: All defects in materials or workmanship on select Bushwacker branded products properly installed per provided instructions. For How Long: This warranty, and any implied warranties including merchantability and fitness for a particular purpose, lasts three years from the date of purchase. The warranty expires if the product is removed from the original vehicle or if the original vehicle is transferred to another owner. The warranty is not transferable from the original purchaser.

## Limited One Year Warranty

What is Covered: All defects in materials or workmanship on select Bushwacker branded products

properly installed per provided instructions.

For How Long: This warranty, and any implied warranties including merchantability and fitness for a

particular purpose, lasts three years from the date of purchase. The warranty expires if the product is

removed from the original vehicle or if the original vehicle is transferred to another owner. The warranty is not transferable from the original purchaser.

What Bushwacker Will Do: During the applicable warranty period listed above, Bushwacker will, at its option, either repair or replace any defective product at no additional charge. You must pay any labor charges associated with removing or reinstalling the product.
